

# Using Yammer for Communications for all members of BCRPVPA

**BCRPVPA Yammer** is a closed communication tool available only to BCRPVPA members. First, you need to sign in to become a Yammer member and you will be joined to the All Network Group. You will find links to Yammer from the Landing Page of the new BCRPVPA website. Just click and follow.

You will be asked to enter your email address, then click on 'Sign Up'. This is then sent to the BCRPVPA admin account to verify that you are a member of BCRPVPA. Once you have a Yammer account you can begin to use it.


## Why Yammer?

This tool is a Social Network, such as Facebook or LinkedIn, meaning it has many features for sharing such as posts, photos, files and videos as well as private messaging. The big difference is it is not open to non-members. One feature that makes it very useful is Groups. Members can create Groups on any topic and choose to leave the Group Open to others to join or make it Closed to only those it would interest or pertain to.

All the posts or files or any other content in that Group are in one place and searchable (especially if 'tagged' when added). Suppose you are planning a trip and want to see if anyone else has been to your intended destination. You would go to the Travel Group and search for 'Cuba' for example, and see all the info that has been added. Of course this becomes more useful if everyone adds some content.

## Messages

The Message function is secure and private or you can choose to post to a group.




## Groups and Conversations

Yammer is similar to other social media. It was designed for in-house use so sharing comments and ideas is one of its main functions. You can also post photos to Yammer.


### Create a Group

Groups can be either Open or Closed, depending on the purpose, for instance the Travel Group is open to all members. Here you can post comments, questions, photos, videos, or links to websites you think others would enjoy. A closed group, on the other hand, is only open to the members of that group and is controlled by the creator of the group. An example of this is the Executive Committee Group.

Posting to a Group is easy. Just select the Group and start writing.




You can Search within a thing.

You can Share photos or files or Send them privately to another member.




## Downloading Files

Find the file you want to download and click on it.



Yammer will go to the page where that file is located, but you will need to download it to your computer. You cannot open it directly in Yammer. Look for the Download button on the right of your screen.

If you need help with Yammer join the 'Support For Using Yammer' Group and ask a question.

The best way to learn Yammer is to jump in and try things. You can do that in 'Support For Using Yammer' where we are all learning together.

## CUBAN ADVENTURE

Have you considered travelling to Cuba? When the opportunity to travel with some new friends arose, my wife and I eagerly made plans. We were only going for a short time as a reprieve from the ice and snow of winter, so we knew that this would be a “highlight” experience.

We had just one day devoted to Havana, and so we arranged with our travel agent at the resort to have a vintage cab with driver/guide for the two hour drive, a guided tour of Havana, and return trip.

A 1957 Oldsmobile pulled up as arranged, and when I climbed in, I was transported back in time. The seats were covered in plastic, and as I examined the dash, details from my parents' 1958 Oldsmobile flashed in my memory. Our guide began the tour, and explained how the original engine had been replaced with a diesel one, and how it was no longer automatic, but a car with a standard shift.

I looked at the door panel and realized there were no handles to open the windows. Our guide handed me a crescent wrench – the tool to wind the window up or down!

We enjoyed our tour of the old Havana – walking through the four major squares, and peering in and exploring courtyards of old mansions. We passed Ernest Hemingway's favourite Mojito bar, and drank in the atmosphere of women singing the praises of the peanuts they were selling. I came across Cuban school kids lining up on a school outing, and a scene where a father was posing his well dressed son for a photograph.

Our guide took us to “Paladar Dona Carmela,” near La

Cabana's fort for a delicious Cuban lunch of chicken, rice and beans. Paladars are privately run eating establishments, often in a private home. A photo of Beyoncé, taken when she visited Havana and ate at this establishment, is proudly displayed.

After lunch, we climbed into the car, and I asked our driver for the wrench to open the window. “No problem, I will turn on the AirCon for you,” he said. This car had also been fitted with air conditioning! We sped down the freeway towards New Havana. Our estimated speed was 100 kmh. I say estimated, because the speedometer no longer worked, but we sped along, passing cars right and left.

Suddenly a sharp noise, and sputtering sound caused our driver to pull to the side of the road. A quick look passed between our eyes and he climbed out, and opened the hood. The AirCon belt had snapped! And in the process, it sliced the radiator hose in two!

We stood off the freeway, as our driver assessed the situation and tried to fashion a repair using a smaller hose and some tape. Numerous vintage cabs pulled off and stopped to see if they could help. It was interesting to note the camaraderie of the drivers – they were all willing to assist in any way they could.

The bad news? Our day tour would have to abruptly end. The good news? The repair job seemed to work, and the containers of water in the trunk came to good use. We viewed the mishap as an adventure that would make our Havana trip memorable, and that created a reason to return sometime in the future to complete our tour!

## Principal & Vice-Principal Personal School Files

When it comes time to move schools or to retire many Principals and Vice-Principals are faced with the task of culling their “personal files” that they have accumulated over the years. This may include their own notes on a variety of situations including students, teachers, support staff, district memos, staff meetings etc. All files relating to formal reports (students, teachers, support staff, maintenance, equipment inventories, etc.) must be left at the school or district.

The School Act and Freedom of Information Protection of Privacy Act, as well as School Districts Policies guide and direct the expected treatment of such files.

The School Act Section 79 (1) requires the School District to:

establish written procedures regarding the storage, retrieval and appropriate use of student records, and ensure confidentiality of the information contained in the student records and ensure privacy for students and their families.

To ensure a high degree of consistency in record keeping, procedures have been written in keeping with district requirements and the School Act and Freedom of Information & Protection of Privacy Act. All student records remain the property of the School District.

### Teacher Files

As per Section 31 of the Freedom of Information and Protection of Privacy Act, if a public body uses an individual’s personal information to make a decision that directly affects that individual, the public body must retain that information for at least one year after using it so that the individual has a reasonable opportunity to obtain access to it. Districts usually keep this information in a permanent file.

Records relating to the student’s annual activities and work, including interim marks and other related information (such as the learner portfolio and samples of work) are retained in the classroom for the school year.

Freedom of Information Protection of Privacy Act

Retention of personal information

31. If an individual’s personal information

(a) is in the custody or under the control of a public body, and

(b) is used by or on behalf of the public body, to make a decision that directly affects the individual, the public body must ensure that the personal information is retained for at least one year after being used so that the affected individual has a reasonable opportunity to obtain access to that personal information.

It is recommended that when you leave your school that all your files are culled and the pertinent information collected on students should be stored in the Office General Student File (G4). All other information that is deemed to be unimportant should be shredded as per School District Policy.

For teacher files that are stored in your office remove any information that is not deemed as necessary and leave the files for the next principal. District policies usually state that Personnel Files need to be kept for a period of 7 years after the employment ceases.

For any investigations conducted and/or disciplinary measures that you have undertaken you should maintain this information in the Teacher’s Personnel File. For any such information that you have retained in student related issues that should be stored in the Students General File or their Confidential Student File.

It is usually recommended that you do not take any of your personal files containing private data and information about students, families, teachers or support staff with you when you retire. However; there may be situations that you wish to keep your “black book” of personal notes on challenging situations that you have dealt with in a secure location at home. If in doubt, contact the BCPVPA or your District for support in this matter.

# Planning a river cruise



Planning a river cruise or an exotic tour ... Jerry Van Dyke "Journey" touring company - <http://jerryvandyke.com/> - just remember that and you won't need anything else. They do NOT advertise so look it up and compare ALL costs. We [My wife Carol and I (Rick)] decided to do a river cruise. We'd always wanted to and avoided it because of the cost; however, we came into some cash, decided to spend it and ended up on a cruise of the Main and Danube rivers, from just south of Frankfurt, Germany to Budapest, Hungary ending in Vienna, Austria. on the Da Vinci river cruise ship - a cruiser carrying only UP TO 113 guests [we intentionally had only 84 - two busloads for excursions]. .... Upon "proofing" this I wondered if I was a paid shill for Jerry Van Dyke's touring; if you knew me, you would not even consider this possibility. I am a bit of a "critic," especially when it comes to spending money unnecessarily - I LOVED this experience. We are saving for the next one!

Now - I know what you will say AFTER you look at the overall price - "it is too much." That's what we said until I priced out the cost of other river cruise line costs + air fare + excursions + etc. It came out to within a couple of hundred dollars AND everything on the Jerry Van Dyke cruise - and I mean everything [air fares, excursions, etc.] - was provided.

The differences that made me "go for it" ...

2 storeys of bedrooms on the Da Vinci, and, as I had learned, the "sun roof" could be lowered to go under a bridge AND we would / could stay on deck. A HUGE difference as there are 60+ bridges that the cruise ship goes under. I was told that on the 3-floors-of-rooms ships the guests must return to their [balconied] rooms each time the ship goes under a bridge. So - either you resort to seeing only 50% of the view OR go up and down constantly.

The Jerry Van Dyke cruise ships only cruise in day

time and "overnight" in ports - We left just south of Frankfurt, Germany [most of the river to the west to Amsterdam is lined with industrial plants - do you REALLY need to see that] on the Main River. Only cruising in the day time meant two things - we had a 360 degree view from the sun deck of ALL of the river, castles, villages, etc. AND we over-nighted in village ports where we were able to visit the villages in the evenings, or for dinner [AFTER receiving our 20 Euro bills], or just walk around and come back for a gourmet meal and a glass or two.

The "small-group" excursions were worth the entire cost in my mind. I NEVER had to rush, could hear the local guide, got local info, ... we loved it!

We did an evening cruise around Margaret island in the Danube near Budapest that was TRULY magical. We went past the fully lit Hungarian Parliament building, while a Hungarian dance troupe entertained us and live, Hungarian, gypsy violin music played - fantastic!

Food was outstanding! Buffets, dinners, wine, etc.

Our one window room was tiny but was efficient and we mostly only slept there.

At our own cost, we stayed an extra 5 days in Vienna [after our cruise] in a room-for-let diagonally opposite the entry to St Stephen's Cathedral. LOVED it!

The following is a REAL experience that tells so much: One day, early in our journey, we were in a group of about 21 being guided by a local guide who I could hear and who was VERY informative. Now - I have NOT been a tour person until this trip so - know that. We were waiting for a "\_\_\_\_\_ " Tour group

of 60+ people quickly following a guide with a colored umbrella running ahead as they hurriedly returned to their ship. They had to be back to leave the town, cruise that night and miss all the view to the east of the town on the Main river. This happened after we could have received a 20 Euro note as we departed the Da Vinci [we chose not to that time]. ..... I know it is OUR money but when was the last time you had that experience? I have NEVER had it.

ADVICE? – go on a “small” ship, and “have your ice-cream with your apple pie” – why not? When will you do this again? GO for it! If you must reduce expenses for a year or two after, do it!

What will you see? Well – there is so much but – this was our itinerary [I don't know if it is even still offered]:

DAY 1 – Aug 6th

We flew to Toronto and were greeted at Toronto airport and were assisted with our check in. We met our Journey Manager and fellow travelers. We flew to Frankfurt airport, took a bus to the Main River to the south, boarded the Da Vinci, received our room and had dinner.

DAY 2 – Aug 7th

We cruised the Main River to Wurzburg, Germany, toured the town and spent the night. WHAT AN INTRO! Journey Mgr got sick and owner of company, Jerry Van Dyke, joins us on the trip

DAY 3 – Aug 8th



In the morning, while breakfasting, we cruised the Main River to Bamberg and had a fantastic guided tour of Bamberg, the Venice of Franconia. Our local guide shared

the river, the massive cathedral, and the Neue Residenz with its rose garden among other things. Overnighed in Bamberg.

DAY 4 – Aug 9th

The next morning we cruised to Nürnberg [Nüremberg] and had a tour of the city with a history unlike any other in Europe. We saw where Hitler gave his speeches and this was all explained by a very ... conflicted ... local guide. Most interesting. We overnighed in Nürnberg.

DAY 5 – Aug 10th

We enter the Main Danube Canal and experience the beauty of the Altmühl Valley from the sun deck as we cruise the heart of Bavaria and one of the most scenic parts of our river cruise. We enjoyed free time in the town of Riedenburg. My wife and I went to an evening concert in the church, and a “festival” in the village square where we had a glass of wine

DAY 6 – Aug 11th

We cruised on to Regensburg – a well-preserved medieval city, toured it, overnighed there and even had a local beer.

DAY 7 – Aug 12th

A beautiful morning cruise took us to Passau. What an outstanding city!

We overnighed there, had an OUTSTANDING Bavarian meal [complete with crew costumes!] and then cruised on to one of the gems of the trip – the Wachau valley (wine!) town of Grein – a SMALL, authentic village .

DAY 8 – Aug 13th – we toured the village of Grein, with a hilarious local Social Studies teacher and his friend as our guides, visited a theatre/jail built in 1562, a beautiful old cathedral, and enjoyed a “concert” put on by the guitar-playing teacher and a glass of local “smoked” beer.

DAY 9 – Aug 14th

Out next visit, after cruising, was another gem of the trip – the Austrian Wachau valley, the Durnstein vineyards and the Benedictine Melk Abbey. All I can say is my wife left the abbey feeling like somehow we had betrayed someone – there is not a square inch of the abbey that is not covered in marble, hardwood or gold; it will take your breath away! The history of this region alone is amazing – look it up! We also enjoyed a ship BBQ as we cruised during the day.



Frankly, I have so many spectacular photos, I did not know which ones to choose.

DAY 10 & 11 – Aug 15th + 16th - VIENNA

We overnighted for 2 nights in Vienna, experienced a guided city and cathedral tour AND of the Hapsburg Schonbrunne Palace [and a self-guided tour of it's amazing zoo] AND a “seats-reserved-by-the-tour“ Vienna Philharmonic concert at the palace that night. It was amazing AND we were coming back for 5 days!



Etc.! Once again – tough to choose photos!

DAY 12

After the 2nd “concert night” in Vienna, we cruised to Budapest – WOW! What a great [dual] city - Buda + Pest [see you learned something already!] We ate a

fantastic buffet as we cruised, went to the Fisherman’s Bastion viewpoint, the Cathedral, the annual market outside the castle.... What an outstanding look at a great city. And there was more!



Because, that evening we did a night cruise around Margaret Island in the Danube with Hungarian dancers, Hungarian Gypsy violins – a memory until I die! I am only going to show you one [of MANY] photos. They remain some of the best I have ever taken.

After 2 nights in Budapest and we cruised back to Esztergom, Hungary and Bratislava, Slovakia and then to our departure port of Vienna where my wife and I stayed [in front of St. Stephen’s Cathedral!] an extra 5 days. I will toss in a few more photos but, honestly, I do not know which to pick. There’s those at the Captain’s dinner, at the Esztergom market, in Bratislava ..... ?? This means one must have no new treatment, or new medication, no new symptoms, or change in frequency of symptoms, no hospitalization or referral to a specialist for the 90 days prior to travel. The Prestige plan is less restrictive and covers sudden and unforeseen medical emergencies.

There is no obligation for a member to take advantage of this option for their health and travel insurance needs. The BCRVPA is endorsing it as an affinity benefit, and advises members to consider whether the Prestige program fits the need for their personal circumstances.

Should a member decide to move from Pacific Blue Cross, it is a matter of notifying the Pension Corp as to their decision. Once a change in coverage is made, should a member decide to return to their Pacific Blue Cross coverage, it is possible if they give a 90 day in advance application.
