Belairdirect and Medoc: we have signed a BCRPVPA contract with them and will receive 1.5% royalty in October of each year. As of September 20th we can now use our BCRPVPA code to get benefits. Please contact them to change to BCRPVPA as we get a better rate with Medoc. Must clearly inform them that you are <u>retired</u> principals and vice principals as there is a confusion with BCPVPA. Update on our financial records and reporting - Deborah Luporini

Presently all our financial recordkeeping is done through the BCPVPA finance department. The BCRPVPA will be taking the financial records and reporting, and the BCPVPA will assist us with the transition. Our completion date for this process is December 31, 2024.

- •We are considering non-profit organization status, and accountants/bookkeeping for non-profit organizations as an alternative to the BCPVPA.
- •It is critical that however we reform ourselves in this area, that we continue to support our members in the ways we have been doing, and we continue to be able to award scholarships/bursaries to students in BC.
- •Lanny Young is gathering information from accountants who support non-profits organizations.
- •Deborah Luporini is taking the lead on researching non-profit status, regarding the request related to scholarships and bursaries, and she will begin the process for NPO status if this is the best option. If there is another option Deborah will communicate this.
